Our house style is classic and refined, combining both traditional and modern winemaking techniques to make superb handcrafted wines of complexity, depth and intensity. Grand Barossa Chardonnay displays aromas of citrus fruits, melon and white peach leading to bright tropical fruit flavours on the palate with a refreshing acidity. On the finish there is a hint of vanilla and cashew nut from partial French oak barrel maturation making it the ideal accompaniment to chicken, fish, pasta and pork dishes with creamy sauces.
