Sustainable practices in our farming benefit the land, our community, and the quality of our wines. This Pinot Noir comes from our Las Brisas (83%) and Mahoney Ranch (17%) vineyards. The wine exhibits balance, highlighting the red fruit, spice, and subtle oak that typify a classic Carneros Pinot Noir.
