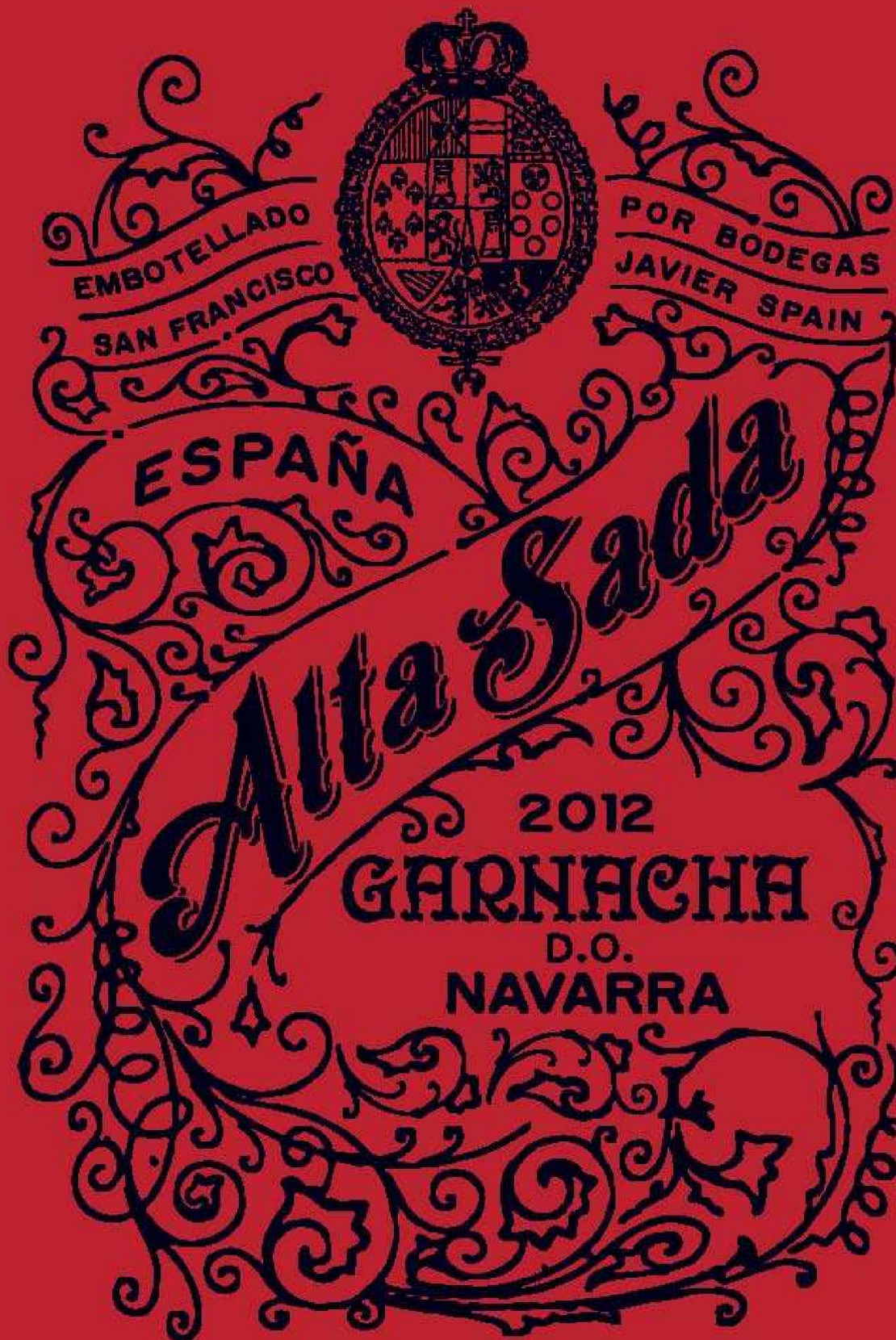

Our bodega was founded in 1939, in the tiny (fewer than 200 inhabitants), high-altitude village of Sada, where the climate is dominated by the cooling influence of the Pyrenees. Thanks to old vines (average age 70 years) and a long, slow ripening period, our wine is a rare, intense aromatic expression of Garnacha. Full fruited on the palate, with ripe blueberry and forest fruits, touches of violets and hints of wild mountain herbs, it has a delicious depth and balance and a lovely fresh, lingering finish.
