Appellation Gevrey-Chambertin Protégée

Since the 17th century, the Dugat-Py domain has owned vineyards in the Gevrey-Chambertin area. "The Jewel of the Grands Crus". Loïc Dugat-Py thus keeps an ancestral know-how alive regarding the work in the vineyard, wine making and maturing, in one of the oldest cellars in Burgundy. Most of the wine growing plots of the Domain consist of very old vines, some of which are over 100 years old. We partly use a horse-drawn plough to till our plots and we do avoid weed-killer, pesticide, chemical treatment or any synthetic fertilizers. The combination of these various elements enables the grapes to reach their optimal maturity and generates a perfect density, long tasting aromas and a unique texture. Thus emerged the concept of offering "Haute Couture" wines, symbols of exacting quality and exclusivity.
