This "Amber" wine is a 50-50 blend of two indigenous grapes from the country of Georgia, Rkatsiteli (ra-ka-see-tell-ee) and Mtsvane (ma-svah-nay). For those of you who are not accustomed to white wines that are made with skin contact, this amber wine is your best chance to start enjoying this style of wines. The wine is fermented and then macerated in large clay jars buried under the ground, called Qvevri, for one month. This is a friendly version of Kakhetian Qvevri whites, with rich flavors, but light tannins and floral notes. Explore this wine with a wide range of foods.
