Our southern slopes offer 180 degree vistas, and a range of soil depths throughout the diverse microclimates which provide a full palate of gorgeously balanced fruit. Our grapes are hand-picked, hand-sorted and fermented in small open-top tanks. The wine is then aged in the tightest-grained new and seasoned French oak for a minimum of 22 months. We believe our wine tastes best when opened amongst colleagues, friends and family.
