Château Tanunda, Icon of the Barossa, was established in 1890 and is the site of some of the Valley's earliest vines as well as its first winery. Privately owned by the Geber family who continue a tradition of fine winemaking spanning three centuries.

50 Year Old Vines are revered for their fine quality fruit and deep root structure bringing diversity of flavour and character. The sandy loam soils of this select single vineyard site deliver a savoury palate.

Hand-crafted, minimalistic winemaking using small open fermenters, gentle basket pressing and aging in the finest French oak for 24 months, ensures the rare qualities of the vines are embodied in the wine. The wine is defined by a swathe of dark fruit flavours, spice and a top note of red fruits. Generous dark chocolate tannins culminate in a long ascending finish. Enjoy now or cellar for up to 15 years.
