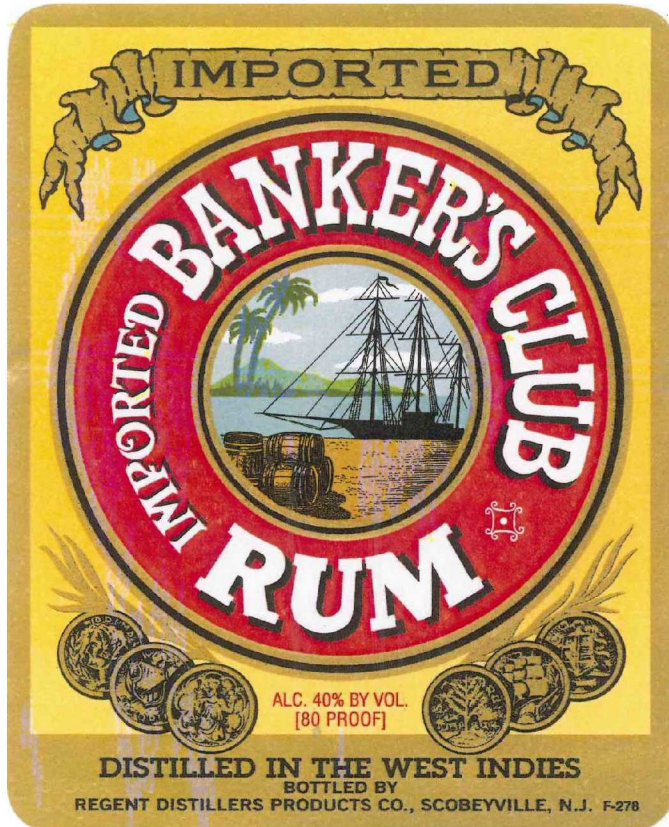

RUM & TONIC Pour jigger of Rum over ice cubes in a tall glass. Fill glass with tonic (quinine water); and add a slice of lemon or lime

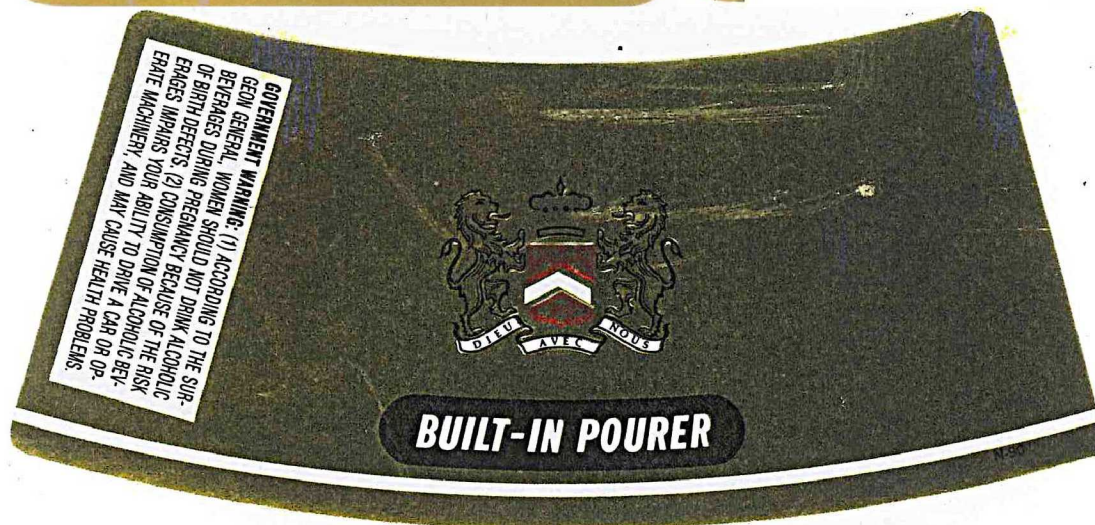
RUM & COLA Pour jigger of Rum over ice cubes in a tall glass. Fill glass with Cola. Add a dash of lemon or lime juice.
