Trentadue Winery's **OPR**, our **Old Patch Red**, originated from a patch of vineyard land planted in 1896. These pre-Prohibition old vines were the original source for OPR.

Today, it is a blend of Zinfandel, Petite Sirah, Carignane, and Sangiovese from low-yielding vines with deeply concentrated flavors. This wine has abundant boysenberry, black cherry, and plum flavors with a whiff of roasted coffee and black pepper. Seductively soft, it has a juicy finish with a touch of spice.
