To reach our special Chardonnay vineyard you must climb the steep, pine tree-lined, spiralling path of the iconic cone-shaped hill on which it lies. Once the site of a pre Roman temple, these high altitude vineyards (700 metres above sea level) not only boast breathtaking views of the Trento valley and the snow-capped Dolomite mountains, but produce really elegant Chardonnay with crisp, lemon notes and a refined mineral edge. Following fermentation, I aged a third of the blend in French oak barriques for eight months to add smooth vanilla notes and a richness to the bright fruit palate. The ripe golden apple and subtle smoky notes make this wine the perfect partner for Osso Bucco, roast chicken and creamy mountain cheeses.
