The BMA forest and vineyard is located 950 m above sea level, ensuring slow but ideal ripening of the grapes.

The whole harvest passes over a sorting table and only the best grapes from each bunch are chosen. The production process uses gravity to avoid pip damage, and long fermentation at low temperatures to retain the aroma. Our wines are aged for twelve months using new barrels, 90% French oak and 10% American, every harvest. 95% Tempranillo and 5% Merlot. Some sediment may be present due to the natural production process. Contains: egg
