Each Single Vineyard for 1865 is carefully managed in accordance with its grape variety condition; soil, topography and climate —or terroir—to produce wines with consistently unique personality and quality. 1865 Chardonnay comes from the mystical Elqui Valley, next to Atacama Desert from our vineyard La Chinchilla next to Elqui river, mainly of colluvial origin with angular and heterogenic stones of medium size with a limo-clay component. Highly influenced by the coastal cool windy cloudy mornings that help to protect the grapes from the direct sun effect and allow a slow ripening. The wine was aged in French oak casks, concrete eggs and French oak barrels. We look to have an Elqui identity, with a vibrant yellow with some green color hues, intense mineral taste, fresh, elegant, citric, cinnamon and papaya notes, highlighted typicity that supports the wine complexity from this origin.
