*Lekkerwijn* (meaning 'nice wine') was granted to the Huguenot Henri l'Ecrévent in 1690, when the neighbouring farm Delta (then called Zandvliet) was granted to Hans Silberbach. Locals were unable to pronounce l'Ecrévent's name, so he became known as Arie Lekkerwijn. Silberbach slew him in 1697, allegedly during an argument over Silberbach's wife Ansela van de Caab, a freed slave. He escaped punishment by taking flight and was declared 'veldvlugtig en vogelvrij' (to be shot on sight). His property was confiscated and he was never seen or heard from again.
