Distinguished by a delicate nose with subtle brioche notes, the wine has a palate of considerable depth and balance with hints of honey and fresh fruit with a long, vibrant finish. A customary Taittinger house saying holds that: "You'll know the soul of a house from the quality of its non-vintage champagne."
