The 2017 100% Cabernet Sauvignon – is the first we've produced from vineyard to bottle. At the heart of Stags Leap District, the smallest AVA in the Napa Valley, is the Hirondelle vineyard. With 20-year old vines – Block A1B is a small three-acre block dedicated to Secret Door Winery. The Cabernet Sauvignon Clone 4 was planted in 1996. Wines produced from the Stags Leap District are noted for being subtle and smooth, focusing more on the aromas and textures rather than raw power.

This wine was pressed and in barrel prior to the October 2017 Napa Valley fires.
