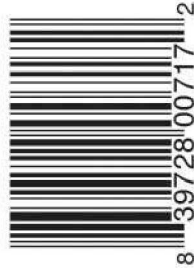
The Acronym Pinot Noir is a silky sipper with bright raspberry and plum flavors. This wine pairs beautifully with pork dishes or is great simply on its own.
