

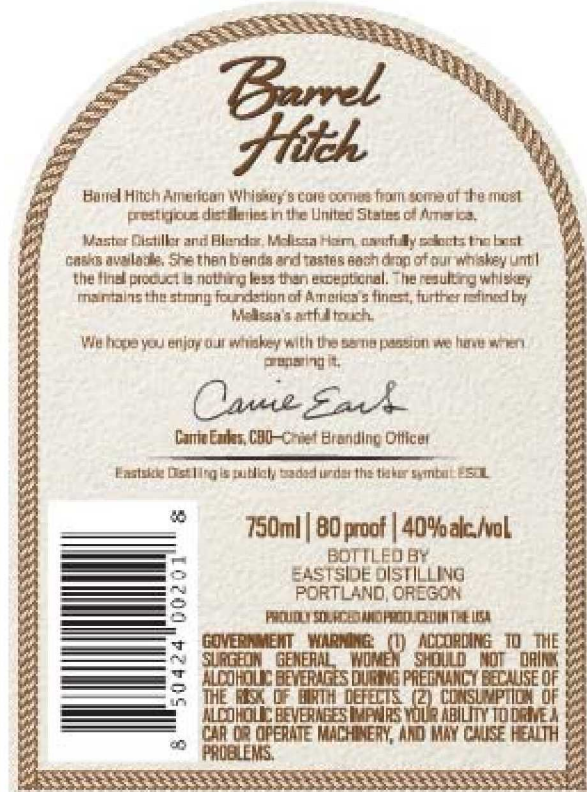

Barrel Hitch American Whiskey's core comes from some of the most prestigious distilleries in the United States of America.

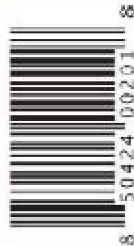
