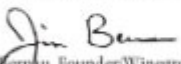

Our Barrel Select Pinot Noir gains greatest complexity through careful blending of outstanding vineyard lots. Pinot Noir, a thin skinned winegrape, develops a natural defense against botrytis (mold) in our moist, cool climate - the antioxidant resveratrol.
