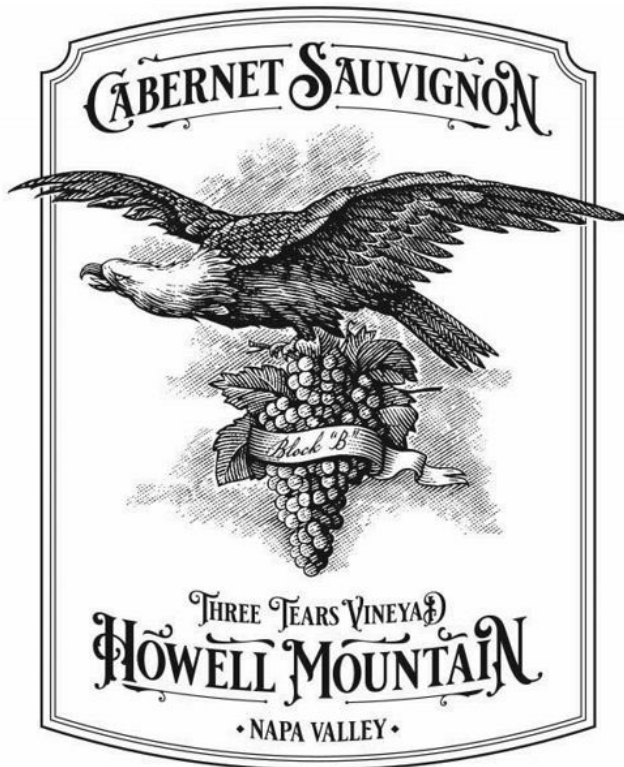

Three Tears Vineyard is planted in volcanic soil across three unique terraces that ascend from 1,600 feet to 2,100 feet on the eastern face of the most northern edge of Howell Mountain. This location benefits from early morning sun that allows the fruit to warm at dawn and fall into shade during the intense heat of the day. The results are wines with concentrated mountain fruit, balanced acidity, and velvety smooth tannins. In no other place are these characteristics more pronounced than in the deep red, rocky volcanic soil of our Block B. The grapes from this narrow bench produce wines with a distinct expression, not only for this extraordinary vineyard, but also for the appellation as a
