Vinification

Grapes arrived by daybreak; sorted by bunch and by berry; separated into individual ferments; 0% to 50% whole clusters; cold soak for 5-6 days; native ferment; punched down daily 1-3 times; 12-16 days on skins; gently basket pressed; fed by gravity to French oak barrels; 60% new oak; aged 16 months; gentle filtration and fining.
