Vinification

Fruit arrived at the winery by daybreak; the grapes were sorted by bunch and by berry, berries were kept whole with each clone separated, -20% whole clusters; 5-6 days cold soak, native fermentations, gentle punch downs 1-3 times daily; 14 days skin contact, gently basket press; transferred by gravity to French Oak barrels; aged on lees for 6 months; bottled unfiltered.

Site

Our Annadel Gap Vineyard is influenced by the cool fog from the nearby Pacific. This combined with the narrowing of the Annadel Gap, concentrate wind flows, creating cool, even gentle growing conditions for optimum flavor and balance. The soil is a fine-grained sandy clay loam, reminiscent of the famous Goldridge soils, interspersed with fractured shale, alluvial gravels and cobbled stone series.
