Torr Na Lochs (*tore nah locks*) Vineyard and Winery overlooks Inks and Buchanan Lakes in the Highland Lakes area of Central Texas. The name translates loosely from the Gaelic language to *hill over lakes* and describes the winery site perfectly. This delicate wine offers aromas of pineapple on the nose, pear on the palate and a crisp citrus finish. This wine pairs well with seafood and spicy foods.
