The 2005 harvest's slow progression of fruit set, veraison and ripening allowed all four varietals to reach full maturity and preserved the levels of color, intense aromas and concentrated fruit. The firm and robust structure, ripe berry nose, and elegant notes of tobacco, toasted coffee and chocolate give this wine great length, along with sweet vanilla notes from 12 months in new French (80%) and American (20%) oak barrels. This wine from Chile's Aconcagua Valley will be best from 2007 thru 2011, but will hold longer.
