Made by Ben Riggs and his winemaking team, this wine displays floral and fresh fruit characters on the nose, with a clean and minerally finish. The wine has a lovely balance and charm which is a beautiful reflection of the Clare Valley region and a fitting tribute to visionary farming families like those of Thomas Goss.
