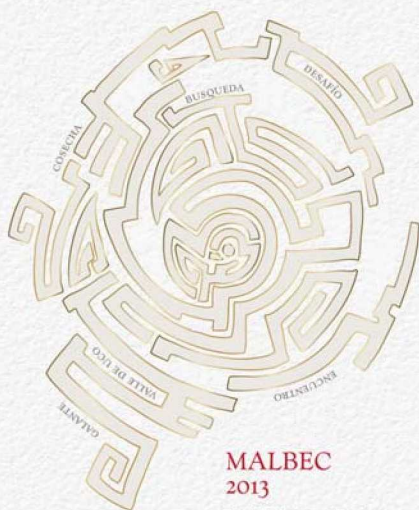

For this 2013 Malbec we hand-picked grapes from Eugenio Bustos, Campo de los Andes, and Chacayes, resulting in a wine with an intense violet color and lush flavors of spice, red fruits, and blackberries. The body is elegant with round tannins, and the wine saw 12 months in French oak barrels.

We invite you to discover in each bottle of Puramun the result of this passionate and endless search.
