This wine exhibits a pretty dark ruby colour with tints of violet. From the offset, the nose shows notes of ripe red fruits combined with subtle floral notes, where iris and violet prevail. On the palate the wine is at once plump, intense and supple. The tannins show a great finesse, revealing excellent potential.
