Our Sauvignon pays tribute to Louise de Bourbon and the thirty-five other Abbesses – all members of the French nobility, who reigned at the Abbaye de Fontevraud from 1115 to 1792. A major figure in the history of the Loire, Louise oversaw the expansion of the abbey between 1534 and 1575. Her motif, the L ailé (or winged L) can be found throughout the building in carved marble panels and decorative floor tiles. This is a densely layered Loire Sauvignon, refreshingly crisp with bright lemon and grapefruit character, a hint of green apple and a zesty lime finish. A thrilling example of Sauvignon from 2018.
