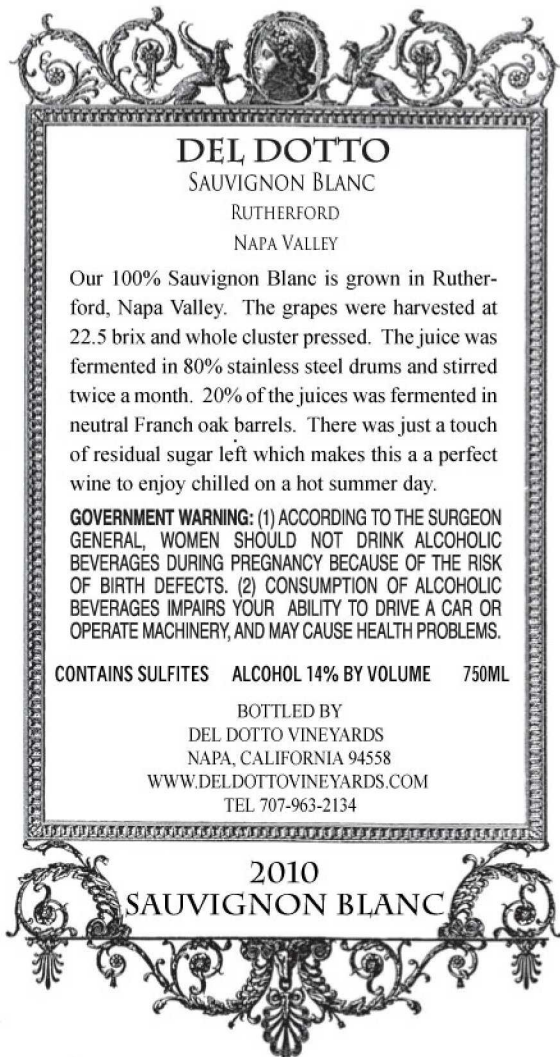

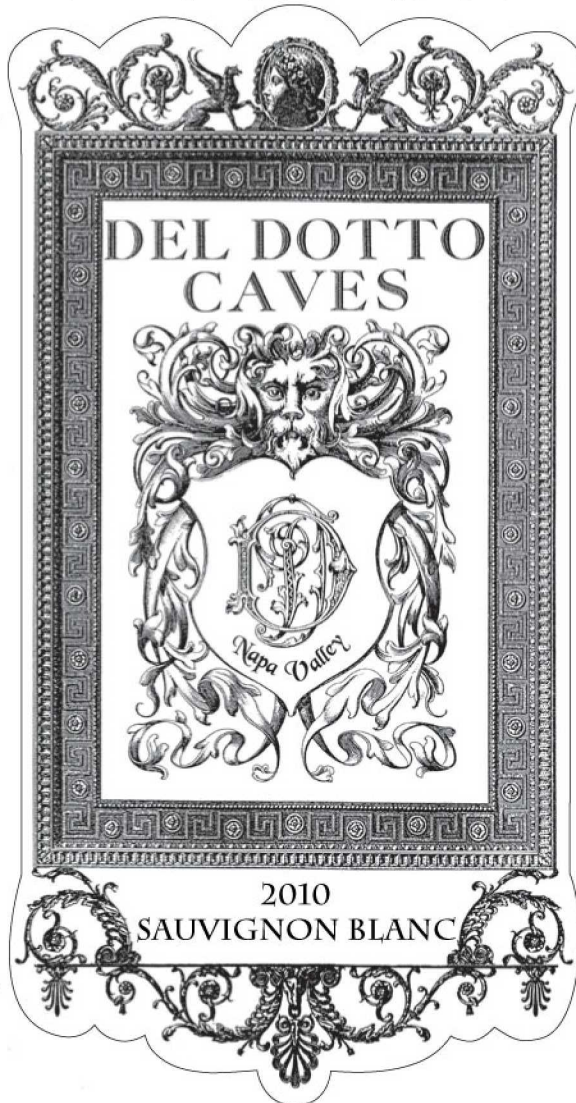
Our 100% Sauvignon Blanc is grown in Rutherford, Napa Valley. The grapes were harvested at 22.5 brix and whole cluster pressed. The juice was fermented in 80% stainless steel drums and stirred twice a month. 20% of the juices was fermented in neutral French oak barrels. There was just a touch of residual sugar left which makes this a perfect wine to enjoy chilled on a hot summer day.
