Winter was late to arrive, delivering a season's worth of rainfall in March. Spring remained cold, followed by heavier-than-usual summer fog, slowing vine progress for a late September harvest. Thirteen parcels barrel fermented and sur lees aged for fifteen months. This fine chardonnay was an assemblage of barrels showing appealing fruit and elegance.
