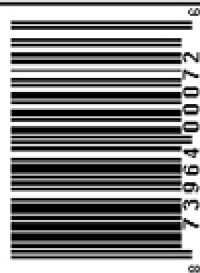

The estate is owned by the dynamic Emeric Petit. **70 % MERLOT & 30 % CABERNET FRANC** planted on slopes of gravel and clay. 25 year old vines. Manual harvest. Cold maceration and long slow fermentation. Aged 12 months in French oak barrels. *Deep purple-ruby robe. Intense, complex nose of plums, spices, vanilla and toast. Round, soft, palate with excellent structure and rich, silky tannins.*

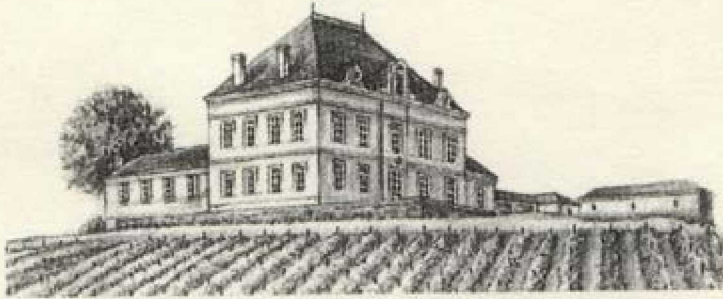
