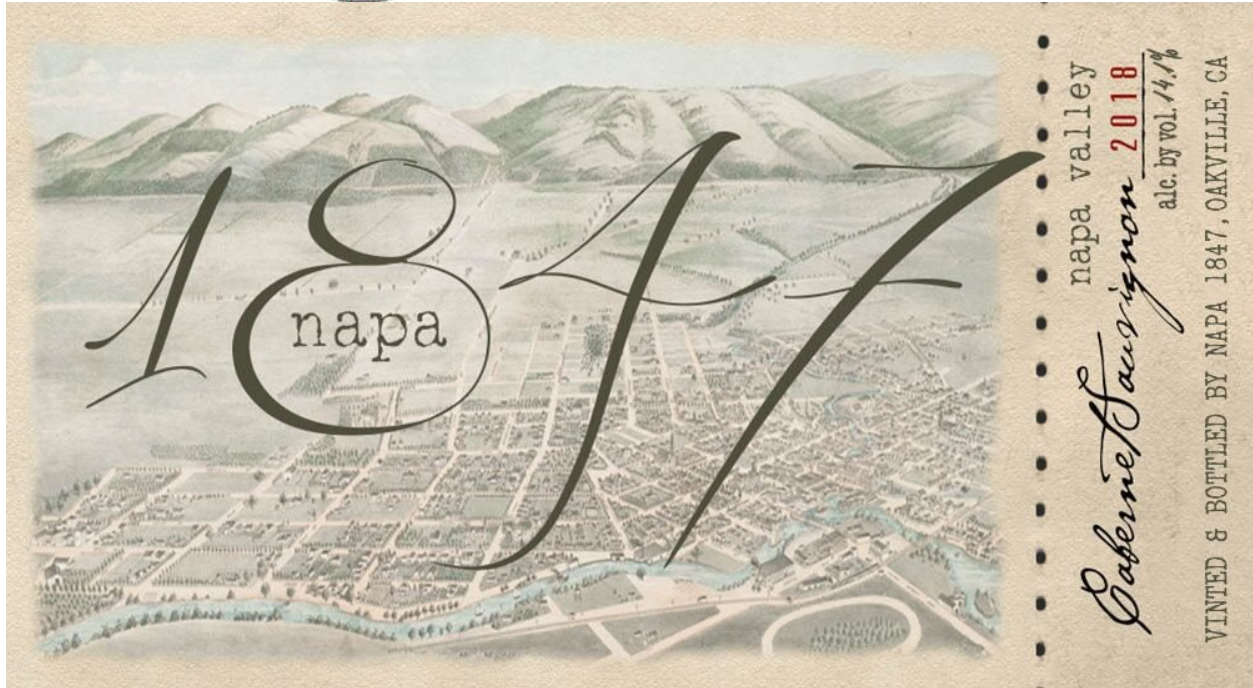

The original town plat of Napa City was planted in beans in 1847, which was the first evidence of civilization in the area. There was not a house in the county except a few adobes. Early in May, 1848, the first building was erected, a saloon, which formed the nucleus around which the present city has grown. The river ferry marked the beginnings of a progression of boat and stagecoach service that greatly influenced the growth of Napa. In 1850, the first steamboat navigated up the Napa River from San Francisco. The first commercial wines were produced in the late 1850's. The most important development, however, came in the 1860's with the Napa Valley Railroad. Napa City soon became a place of great prosperity, extensive trade, and a favorite tourist destination.
