Handpicked from select hillside vineyards in the Valpolicella Valley, the Corvina Veronese (30%) and Corvinone Veronese (35%) and the Rondinella (35%) grapes are then naturally dried for the traditional 90-100 days. They are then soft pressed, followed by 30-days maceration on the skins. Aged 24 months in large oak barrels.

The color is deep bright, ruby red with a violet edge. Powerful bouquet and intense aromas of cherry, ripe plum, toasted almond, and vanilla. A full-bodied wine with round and rich flavor.
