Casablanca valley, recognized as Chile's premium cool climate viticultural region, enjoys sea breezes that extend the ripening period of the hand-picked and specially selected grapes, thus maintaining their full flavours and intense aromas. This exceptional Pinot Noir displays a beautiful red strawberry color, with varietal fruit flavors of fresh berries and the added complexity of oak from aging of 50% of the wine in a 5000 lts new french oak conic tank (foudre) for 4,5 months. The remaining 50% was aged in stainless steel tanks. It is a well balanced wine with an extremely good finish.
