The Château is privately owned by the Geber family who continue a tradition of fine winemaking spanning three centuries. For our Grand Barossa Red Blend, we select **Cabernet Sauvignon (50%), Shiraz (30%) and Merlot (20%)** grown throughout the Barossa. It is this tapestry of 'terroirs' which enables us to create our classic and refined house style. By combining both traditional and modern winemaking techniques we are able to make handcrafted wines of complexity, depth and intensity. Lifted aromas of blackberry, plum and black pepper are accompanied by spicy, dark berry fruits on the palate. The finish is long with fine-grained tannins from maturation in a combination of new and seasoned American and French oak barrels. Enjoy now or cellar carefully for up to ten years from vintage.*
