Showcasing the winemaker's preference for young, fresh and fruity wines, this elegant wine expresses the typical characteristics of Bonarda: red fruit, ripe plum, both on the nose and on the palate, balanced acidity and sweet tannins. In the mouth, its body and softness invite you to continue drinking. Ideal to accompany red and white meats and pasta.
