A fifth year of drought threatened to leave the vines short on water. Thankfully late spring storms carried them through a very warm summer. Harvest started two weeks earlier than usual and quality was superb. Short fermentations extracted elegant tannins. Appealing now, the wine shows beautiful fruit, layered with exotic spice, and complex minerals. It will be most enjoyable over the next five years. JO/EB (12/17)
