Product development at Balcones is always driven by curiosity, the interest of the distillers, and the challenge of working with new raw materials. In developing a Rye whisky we wanted to work with a style we love and had yet to experiment with, and still bring some new subtlety and variety to our recipe. We decided to use 100% rye in our mashbill, the bulk being Elbon rye from North Texas, but using some crystal, chocolate, and roasted rye specialty grains.
