Our estate vineyards located in southern Oregon's Umpqua Valley surrendered exquisite Tempranillo fruit which we eagerly harvested in late September. High-toned blue and black berry fruit dominate the aromas with plum, earth, and subtle oak in the background. Flavors mimic the aromas with cedar and graphite complexities carried on a seamless texture. This wine will age gracefully over the next five to eight years and accompany pimenton-honey glazed rotisserie pork shoulder with blue corn polenta or cochinita asado.

In 1995, proprietors Earl & Hilda Jones planted the first Tempranillo in the Pacific Northwest and named their vineyard Abacela, from an ancient and now obsolete Iberian word meaning to plant a grapevine. Successful production of these wines is made possible by our estate's unique Southern Oregon terroir.
