The sun ripened clusters were then hand picked in small bins. The wine was fermented to dryness before pressing, and aged in small French, American and Hungarian oak barrels for 20 months. The result: An engaging fruit-forward wine with soft tannins and jammy overtones that is especially enjoyed with beef, lamb and pasta dishes.
