Stéphanie and Emmanuel Caslot work with their father to make some of the Loire's more serious CABERNET FRANC wines. Caslots have lived at this domaine since 1640, and today it is surrounded by 59 acres of vines farmed without agrochemicals. Harvesting by hand, the family makes a series of single-vineyard wines, and normally bottles without fining or filtration. These are wines rich with meaty fruit, mineral depth, and lip-smacking length.
