Talinay, made by Tabalí captures the pure and natural influences from the untamed coast of Limari Valley in the North of Chile. In a small hidden valley, almost touching the sea, with the Camanchaca fog covering the Talinay hills, this vineyard is the only place in Chile planted over chalky/limestone soil.

This Pinot Noir has complex and mineral notes, with plenty of red fruit and a distinctive earthy character. The palate is full with great texture and finely balanced flavours. Long and captivating finish.
