For our second release of this Rhone-style varietal blend, we selected grapes from three closely planted parcels at our Lytton West vineyard. The grapes were destemmed, but left to ferment as whole berries to moderate tannins and accentuate fruit. Syrah adds color and dark fruit while mataro and grenache contribute structure and aroma. Enjoyable on release, this wine will continue to evolve for another five to six years. JO (8/16)
