Food Pairings: Serve with your favorite fish, grilled chicken, or light pasta dish.

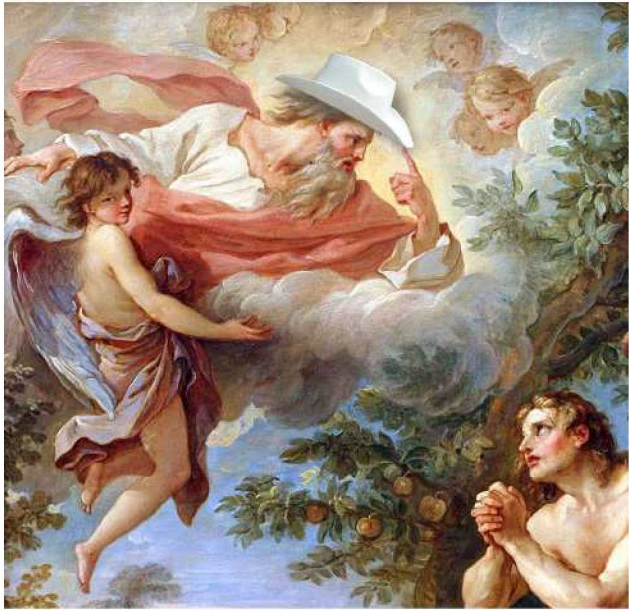
