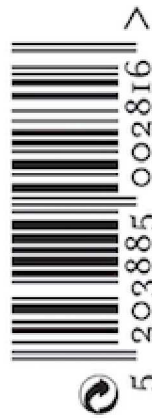

Bone-dry, brightly acidic with a textural mineral smokiness and a food-begging finish.
