Nómade wines are crafted from grapes carefully selected by **Tomás Achaval**, who scours the area surrounding the Andes searching for premium vineyards which benefit from a unique location, significant vine age and experience working culture.

This wine comes from a vineyard located in Uco Valley; Mendoza at an altitude of 3,996 feet / 1,211 meters. We choose to harvest at the very end of the harvest season; third week of April; to enhance fruitiness in particular red and black berry's taste.

Aged for eight months in French and American oak barrels.

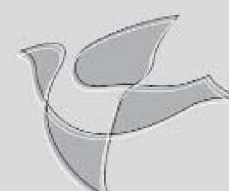
