ALEXANDER VALLEY, SONOMA COUNTY 2010

Vineyard: 5 acres of old vine Cabernet Sauvignon from a small knoll in the southern region of the Alexander Valley.

Topography: Southeastern exposure and gravel loam soils extend grape hang time for maximum flavor development. This imparts a rich, fleshy texture with round supple tannins.

Harvest: Hand-picked on October 27, 2010

Fermentation and Aging: The grapes were gently destemmed into a small tank, where the wine remained for four weeks. 100% Cabernet Sauvignon, aged in small, French Demptos barrels for 43 months at 200% new wood.

Bottling: Bottled directly from barrel to ensure aromatic integrity, the wine is bottled without fining or filtration. As a result, some deposit may show after cellaring. Bottle aging will develop and enhance this wine for many years.
