Our Loire rosé pays tribute to Louise de Bourbon and the thirty-five other Abbesses - all members of the French nobility, and fourteen of them princesses - who reigned at the Abbaye de Fontevraud from 1115 to 1792. A major figure in the history of the Loire, Louise oversaw the expansion of the abbey between 1534 and 1575. Her motif, the L ailé (or winged L) can be found throughout the building in carved marble panels and decorative floor tiles. This elegant wine is crafted from the region's classic red grapes and displays attractive ripe raspberry and redcurrant fruit on the nose and palate. Elegant, fresh and well-structured with a vivid red fruit finish, this is the perfect wine for Summer drinking.

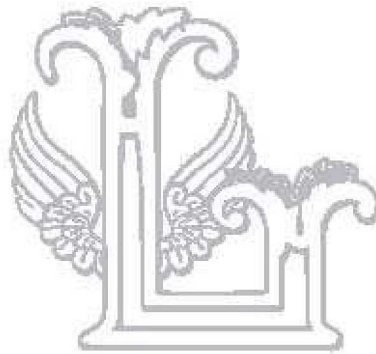
