Torr Na Lochs (*tore nah locks*) Vineyard and Winery overlooks Inks and Buchanan Lakes in the Highland Lakes area of Central Texas. The name translates loosely from the Gaelic language to *hill over lakes* and describes the winery site perfectly. The dark ruby red color of this wine is matched only by the darkness of the cherries and berries on the palate.
