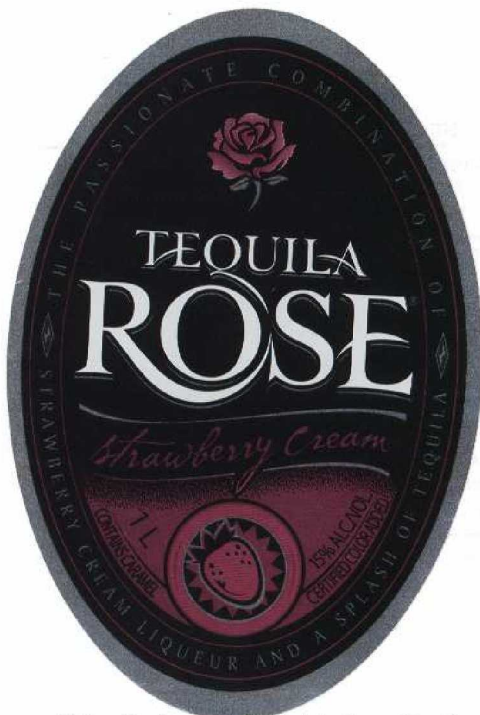
Section 37.11 of the Texas Alcoholic Beverage Code requires each holder of a Non-Resident permit to secure approval of the labels, contents, style or size of containers for each brand of distilled spirit before introducing the spirits into the State of Texas. In order to comply with the above mentioned LAW, please follow the following steps:

DISTILLED SPIRITS:

1. Label application & affidavit (4-MP-17).
2. Copy of Alcohol, Tobacco & Firearms (BATF) Certificate of Approval.
3. Sample of product (in container with labels affixed as it is to be introduced into the State of Texas).
4. Proper fee. (\$25.00 for each size, brand and class). Make check payable to the Texas Alcoholic Beverage Commission.
5. One brand and class per application.
6. In this order staple application, BATF Certificate of Approval and sample of product to the documents in the upper left hand corner.
