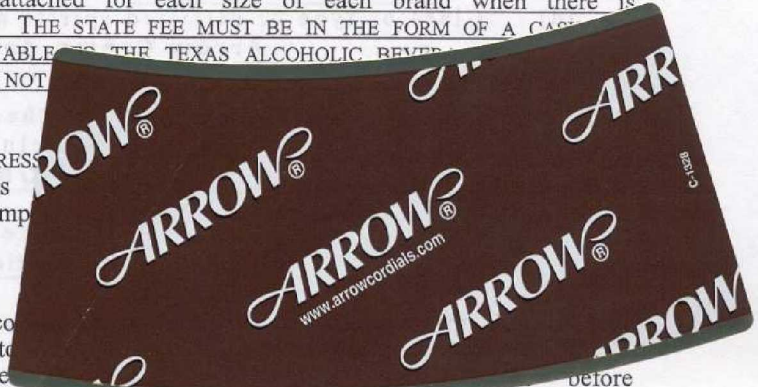

THE STATE FEE MUST BE IN THE FORM OF A CASH CHECK OR MONEY ORDER PAYABLE TO THE TEXAS ALCOHOLIC BEVERAGE COMMISSION. PERSONAL OR FIRM CHECKS WILL NOT BE ACCEPTED.

- (c) Under separate cover EXPRESS PREPAID, for which label approval is required, both the label application and sample label must be submitted.

Section 37.11 of the Texas Alcoholic Beverage Code requires that a Non-Resident Seller's Permit to sell alcoholic beverages in this state be accompanied by a label of the style or size of the container in which the beverages are sold.
